### 1. Introduction

By purchasing, redeeming, or using a Yate & McGrath Limited gift voucher, you agree to be bound by these T&Cs.

- 2. Purchasing a Gift Voucher
- Gift vouchers can be purchased in our studio
- Vouchers are available in set denominations or a custom amount specified by the purchaser.
- Payment must be made in full at the time of purchase.
- Upon purchase, you will receive a proof of purchase (till receipt email confirmation). The physical voucher itself is the item of value.
- 3. Form of Vouchers
- In-Store: Vouchers will be provided as a physically printed card.
- 4. Redeeming a Gift Voucher
- Vouchers can be redeemed against any goods and services offered by Yate & McGrath Limited, including framing commissions, mirrors and framed art work.
- Vouchers cannot be used to purchase additional gift vouchers.

- The expiry date will be clearly printed on the physical voucher.
- It is the responsibility of the voucher holder to use the voucher before its expiry date.
- We are not obligated to honour vouchers that have expired.

### 6. Change and Partial Redemption

- If the order value is less than the voucher's value, the remaining balance will be issued as a new gift voucher with the original voucher expiry date.
- If the order value exceeds the voucher's value, the remaining balance must be paid by another payment method (e.g., cash, bank transfer, card).

#### 7. Loss, Theft, or Damage

- Yate & McGrath Limited is not responsible for lost, stolen, damaged, or destroyed vouchers.
- Vouchers should be treated like cash. We cannot replace lost or stolen vouchers or provide a refund for them.

#### 8. Liability

- Our liability for any issues with a gift voucher is limited to the purchase price of the voucher.
- We are not liable for any failure to fulfil our obligations due to circumstances beyond our reasonable control (e.g., fire, flood, severe weather, pandemic).
